IMMEDIATE SUPERVISOR'S TITLE: Water/Wastewater Plant Chief Operator

PURPOSE

Performs work in the operation and maintenance of water and wastewater treatment plants and collection and distribution system.

ORGANIZATIONAL RELATIONSHIPS

Reports to: Water/Wastewater Plant Chief Operator Coordinates/works with: Infrastructure Department

ESSENTIAL FUNCTIONS

- Monitors chemical feed systems, bio solids level depths, and adjusts control devices such as clarifiers and metering pumps
- Performs daily, weekly, and monthly sampling, laboratory testing, and bio solids analysis
- Prepares liquid bio solids for application sites
- Inspects and maintains equipment; changes oil and wear parts; greases pumps, motors and bearings Cleans and repairs equipment such as pumps, clarifiers, filter, and valves
- Prepares, and assists in the preparation of, required reports. Inputs daily monitoring reports for MPCA reporting.

OTHER DUTIES AND RESPONSIBILITIES

- Provides facility tours and general information to various groups
- Provides janitorial duties in all areas of Pump House, Water Tower, Water Treatment Plant and Waste Water Treatment Facility
- Operates plow truck, skid steer, lawn maintenance equipment
- Performs other duties as assigned
