No license shall be required for any person to sell or attempt to sell, or to take or attempt to take orders for product grown, produced, cultivated, or raised on a farm owned and/or operated by the applicant. No license shall be required of any person going from house- to-house, door-to-door, business-to-business, street-to-street, or other type of place-to-place when such activity is for the purpose of exercising that person's state or federal constitutional rights (i.e., freedom of speech, press, religion, etc.) Except that this exemption may be lost if the person's exercise of constitutional rights is merely incidental to a commercial activity. Professional fundraisers working on behalf of an otherwise exempt person or group shall not be exempt from licensing requirements.

All solicitors and any person exempt from the licensing requirements of this ordinance shall be required to register with the city. Registration shall be made on the same form required for a license application, but no fee shall be required.

No license issued under this ordinance shall be transferred to any person other than the person to whom the license was issued.

MINNESOTA TAX CLEARANCE INFORMATION

Pursuant to Laws of Minnesota, 1984, Chapter, 502, Article 8, Section 2 (270.72) (Tax Clearance; Issuance of Licenses), the licensing authority is required to provide to the Minnesota Commissioner of Revenue your Minnesota business tax identification number and the Social Security Number of each license applicant.
